Exterior Door Limited Warranty

Steel Slabs

Magbee Contractors Supply guarantees and warrants, subject to the conditions and restrictions stated below, that each Masonite Wood-Edge Steel door slab shall be free from any material defects for five (5) years to the home into which they are installed commencing on the original date of purchase and thereafter. Steel slabs are guaranteed not to warp, rust, crack, or buckle in the stated time period of five (5) years. The slab must be painted and/or finished according to Masonite specifications.

Fiberglass Slabs

Magbee Contractors Supply guarantees and warrants, subject to the conditions and restrictions stated below, that each Masonite Fiberglass door slab shall be free from any material defects for twenty-five (25) years to the home into which they are installed commencing on the original date of purchase and thereafter. Fiberglass slabs are guaranteed not to dent, warp, rust, crack, or buckle in the stated time period of twenty-five (25) years. The slabs must be painted and/or finished according to Masonite specifications.

Solid Core Moulded Panel Slabs 1-3/4"

Magbee Contractors Supply guarantees and warrants, subject to the conditions and restrictions stated below, that each Masonite solid core moulded 1-3/4" door slab shall be free from any material defects for five (5) years to the home into which they are installed commencing on the original date of purchase and thereafter. The slabs must be painted and/or finished according to Masonite specifications.

Wood Exterior Door Frame

Magbee warrants their end sealed exterior door jambs against end rotting, for a period of ten (10) years from the date of purchase. All exposed door jambs must be painted with exterior grade paint within 90 days of installation. Failure to do so will void the warranty. It is required that the customer keep and provide all invoices, receipts, and other relevant documents received at the time of purchase or for the maintenance of the door system and its components.

Door Inserts

Magbee warrants their door inserts to be free from any defects in material and workmanship that renders its product unfit for its normal and recommended use for a period of five (5) years from the date of purchase. All frames must be finished in accordance with the manufacturer's recommendations. The warranty does not cover any product installed in, or submitted to high heat conditions, high moisture conditions, high vibration and/or extreme temperature changes, or painted a dark color or installed behind a screen door.

Components Other Than Slabs and Frames

All components other than slabs and wood frame systems (including hinges, sills, weatherstripping, casing) are guaranteed to be free of manufacturing defects for one (1) year from original date of purchase. The one (1) year time frame only includes the original purchase from Magbee Contractors Supply and is not calculated from the date of purchase of the structure such millwork units were installed, nor is it calculated from the date of installation, unless the units were installed by Magbee Installation Services. If the units were installed by Magbee, the warranty is one (1) year from the date of installation. This warranty is in addition to any warranty from the respective manufacturers of component pieces used to make custom millwork items. A Magbee representative must inspect any and all products a customer may believe to have manufacturing defects.

AN INSPECTION FEE WILL BE APPLIED TO ALL ON-SITE PRODUCT INSPECTIONS PERFORMED FOR ANY CUSTOMER FOR ALL CLAIMS MADE BEYOND ONE YEAR FROM THE ORIGINAL DATE OF PURCHASE, REGARDLESS OF APPLICABLE PRODUCT WARRANTIES.

Magbee will investigate as to determine if individual components fall under their respective warranties (if any) to Magbee. In such an event, repairs may be reimbursed partially or in whole to the customer from Magbee through the respective manufacturers.

Special Order Slabs and Units

Special order slabs and units fall under their respective manufacturers warranty. No specific warranty beyond the Magbee warranty of one (1) year from the date of purchase is implied.

General Conditions

The limited warranty is made and extends only to the original purchaser of such items from Magbee and owner occupied single-family residence at the time of initial installation. It may not be assigned or transferred and shall not extend to subsequent owners. In the event the item is replaced according to the terms of this limited warranty, the replacement items are warranted only for the remainder of warranty period applicable to the original item. The provisions set forth herein constitute the maximum liability of Magbee with regard to the product warranted. Except as provided above, in no event shall Magbee pay for the cost of labor, installation, freight or finishing of any replacement unit, or any other incidental costs related thereto. All other claims due to special, indirect, consequential, or indirect damage are also excluded from this warranty. Magbee specifically disclaims any implied warranties of merchantability and fitness for a particular purpose and makes no other warranty or guarantee, either express or implied, except as expressly contained herein with respect to its door units. In the event state law precludes exclusion or limitation of implied warranties, the duration of any such implied warranty and the time and manner of presenting any claim thereon shall be the same as that provided in the express warranty stated herein.

This warranty shall not apply to units sold or installed outside the United States, or units damaged in handling or installation. This warranty shall also be void if the unit is subjected to stresses resulting from: Localized application of heat causing excessive temperature differentials over the glass surfaces, or excessive vibration, or movement of building or foundations.

Claims under this warranty must be made as soon as practicable after discovery of the defect and in all events prior to the beginnings of any repair work to Magbee Contractors Supply. Written claims must detail the nature of the problem and the name, address, and telephone number of the person making the warranty claim. No warranty claim shall be considered properly made unless it contains the forgoing in writing and is received by unit alleged as being defective under this warranty, field inspected by a qualified factory representative and returned to the factory. No distributor, dealer, or representative of Magbee has the authority to change or modify this warranty, either orally or in writing, in any respect.

What is NOT covered by this limited warranty

Textures and color variations do not constitute defects on wood items.

Product failure or damage due to improper installation or modifications including:

- Adjustments or corrections due to improper installation.
- Failures due to product modifications or glass shading devices (e.g. glass tinting, security systems, improper painting or staining, insulated coverings, etc.).
- Units improperly assembled or improperly mulled by others.
- Failure due to the application of non-Magbee supplied products.

Damage caused by the following:

- Damage due to improper installation, maintenance, or use.
- Damage to the product caused by water infiltration other than as a result of a defect in manufacturing, materials, or workmanship.
- Damage due to condensation.
- Damage to glass caused by others (e.g., brick wash, sanding, or improper washing).
- Damage caused by failing to properly seal the exposed wood portions of a product.
- Damage caused by chemicals or airborne pollutants, such as salt or acid rain.
- Damage that occurs during delivery by others.
- Damage caused by accidents or acts of God.
- Damage as a result of normal wear and tear.
- Naturally occurring corrosion or tarnishing of hardware finishes; damage to metal surfaces caused by chemicals or a harsh environment
